On a number of occasions in the past, the World Bank as an institution and the President of the Bank in his personal capacity have assisted in mediation or conciliation of investment disputes between governments and private foreign investors. The creation of the International Centre for Settlement of Investment Disputes (ICSID) in 1966 was in part intended to relieve the President and the staff of the burden of becoming involved in such disputes. But the Bank's overriding consideration in creating ICSID was the belief that an institution specially designed to facilitate the settlement of investment disputes between governments and foreign investors could help to promote increased flows of international investment.

ICSID was established under the Convention on the Settlement of Investment Disputes between States and Nationals of Other States (the Convention) which came into force on October 14, 1966. ICSID has an Administrative Council and a Secretariat. The Administrative Council is chaired by the World Bank's President and consists of one representative of each State which has ratified the Convention.

UNCTAD has a long standing work programme on issues related to international investment agreements (IIAs), looking at their development dimension and focusing primarily on identifying the implications for developing countries by canalizing technical assistance and promoting capacity building. The work is undertaken through an integrative approach that combines research and policy analysis, technical assistance and consensus-building activities.

Specifically, the work programme undertakes research and policy analysis on IIAs through the pink paper series on Issues in IIAs (28 publications), the second generation series on International Investment Policies for Development, various studies (including survey on Bilateral Investment Treaties (BITs) practices), the on-line database of BITs (2.000 texts and lists per country), the compilation of other international investment instruments (including treaty models) and the database of investor-State dispute settlement cases.

UNCTAD's work programme on IIAs also comprises technical assistance and capacity-building activities consisting of intensive training programmes for negotiators of IIAs delivered in all regions, a distance-learning programme on key issues in IIAs (available in 5 languages), as well as ad hoc technical assistance to developing countries and regional organisations.

In the area of investor-State dispute settlement (ISDS), the work programme has expanded its work through:

- Focused training activities (advanced training courses on managing investment disputes),
- Seminars and symposia to inform and create awareness (seminars with OECD, APEC, OAS, ad hoc technical assistance activities to countries...),
- Research and analysis (publications on ISDS (review, impact, negotiating options, alternative dispute resolutions...), IIA Monitor on ISDS trends and implications, database of treaty-based ISDS cases), and
- international consensus-building (UNCTAD's Commission on Investment and expert meetings)

At the last UNCTAD's Investment Commission in 2006, it was recognized that UNCTAD "should serve as the key focal point in the United Nations system for dealing with matters related to international investment agreements, and continue to provide the forum to advance the understanding of issues related to international IIAs and their development dimension, including with reference to investor-State dispute resolution".
