ETHICS TRAIN-THE-TRAINER

The Institute for Law Enforcement Administration, a division of The Center for American and International Law (formerly the Southwestern Legal Foundation), is located at 1778 Plano Road, Suite 212 (Spring Creek Business Center), Richardson, in the northern metropolitan area of Dallas, Texas. Since 1957, it has been nationally recognized as a first rate provider of law enforcement education and training programs. Through a generous grant from the Meadows Foundation, the Center for Law Enforcement Ethics was formed in 1992 to provide opportunities for continuous examination of ethical issues affecting law enforcement. Since its inception, the Center has become a national focal point in this field.

Successful completion of the four and one-half day Ethics Train-the-Trainer program will authorize graduates to present the eight hour Law Enforcement Ethics, the sixteen hour Ethics for Field Training Officer, and four hour In-Service ethics courses within their own agencies or local/regional academies. The Train-the-Trainer course will model the course curricula, afford in-depth examination of the classics in ethical thought, allow opportunities for scenario development, demonstrate interactive learning activities, and provide class management strategies. The program will include such topics as:

- ! Identifying Dilemmas and "Stakeholders"
- ! The Six Pillars of Character and The Principles of Ethical Policing
- ! The Condition of Society: What Does it Mean to Policing?
- ! Higher Standards/Different Standards
- ! Strategies for Creating a Healthy Ethical Environment
- ! Understanding the Present Through the Classics: Teaching Ethics from Solid Ground

FACULTY

Daniel P. Carlson, Associate Director of the Institute for Law Enforcement Administration. A retired Captain from the New York State Police, he joined the Institute in November, 1992, after a distinguished career of 21 years of police service. He attended the Josephson Institute of Ethics in June, 1993, and is editor of *The Ethics Roll Call: Listening to the Inner Voice*.

Daniel T. Primoic, Assistant Professor of Philosophy at Elmhurst College, Elmhurst, Illinois. A specialist in Applied Ethics, he is widely published in the area of Contemporary Moral Problems and Professional Ethics. He holds a Ph.D. in philosophy from the University of New Mexico.

A. Jay Six, Jr., Lieutenant of the Arlington Police Department, Texas. Currently assigned as Commander of the Patrol Division. He holds a B.S. degree in Criminal Justice from the University of Texas at Arlington.

Gregory Smith, Lecturer of the Institute for Law Enforcement Administration. He holds a B.S. degree in Sociology from Ball State University and is completing a M.A. degree in Social Psychology from the University of Texas at Arlington. He specializes in Applied Ethics, Multi-Cultural Education and Social Science.

Gary W. Sykes, Director of the Institute for Law Enforcement Administration. A former professor and author in police administration, he holds a Ph.D. in political science from Pennsylvania State University and attended the Aspen Institute on Ethics in October, 1992.

Instructor availability will dictate faculty composition at individual courses.

COURSE GRADUATES

Since 1993, the Ethics Train-the-Trainer course has graduated over 4,000 law enforcement trainers who have departed the program fully prepared and equipped to teach the ethics curricula in their own agencies or local academies. Course graduates have been drawn from 715 agencies across the United States, Canada and Great Britain.

Through the instructional efforts of these training professionals, thousands more criminal justice practitioners have had the opportunity to participate in either the eight hour Law Enforcement Ethics, sixteen hour Field Training Officer Ethics, or four hour In-Service Ethics courses.

COURSE MATERIALS

Persons successfully completing the Ethics Train-the-Trainer course will receive comprehensive lesson plans for the eight hour Law Enforcement Ethics, the sixteen hour F.T.O. Ethics courses and the four hour In-Service Ethics courses. In addition, masters of overhead transparencies, a PowerPoint presentation disk, ethics scenarios, an ethics game, and a Student Note-taking Guide will be provided. Graduates will have I.L.E.A. authorization to teach these courses in their own agencies or local/regional academies.

This program is best suited for individuals with prior training experience.

COURSE HOURS

On the opening day, registration will begin at 8:00 a.m. Daily sessions run from 8:30 a.m. to 4:30 p.m. Monday through Thursday, and 8:30 a.m. to 12:00 noon on Friday. In order to enhance class discussion and provide opportunities for additional learning, out-of-class readings will be assigned during the week.

Information for Air Travelers
