# 9:30 PRICE FIXING AND BID RIGGING IN THE OILFIELD—KNOW THE ANTITRUST RISKS

Antitrust scrutiny in the oilfield is at a new high. Federal and state authorities in the United States are investigating alleged horizontal bid rigging in the acquisition of oil and gas leases. In Brazil, the Council for Economic Defense (CADE) is investigating an alleged longstanding bid rotation scheme among private firms bidding for lucrative contracts with Petrobras. Depressed oil prices elevate concerns that purchasers of oilfield services may collude with their competitors in an effort to obtain discounted service prices. This topic examines when these and other joint activities by horizontal oilfield competitors may cross the line to antitrust illegality, for example, when lawful joint bidding becomes illegal bid rigging.

#### 1:30 CHALLENGES AND OPPORTUNITIES IN MEXICO'S MIDSTREAM INDUSTRY

Mexico's government-controlled midstream sector has faced years of chronic underinvestment, and there are significant opportunities for the private sector to develop the midstream infrastructure that Mexico will need to accommodate an expected boom in natural gas and crude oil imports from the United States. Although there are currently only 9,000 pipeline miles in the entire country, the Mexican government has already announced 1,000 miles of new pipeline projects, and the country will also need new and expanded terminals, port infrastructure and storage facilities. While the 2013 Energy Reforms brought significant regulatory and structural changes to Mexico's midstream industry, privatization was not one of them, and the sector will remain under government control. This session will explore the midstream opportunities that are available in Mexico and some of the challenges to making those opportunities a reality.
