A Comparative and International Legal Study, (Springer, 2023): Arbitration is facing revolutionary changes due to new technologies' irruption into the entire arbitration proceeding. Wide-ranging technical-legal concepts such as ediscovery, e-hearing, cyber-security protocol, e-deliberations, algorithmic decision-making and digital signing have become part of life. Technology's impact on tion). arbitration is unlikely to decrease after the COVID crisis; on the contrary, how the arbitration community positions itself vis-à-vis technology will be a key factor in determining arbitration's future. Faced with this challenging scenario, the book discusses a novel legal topic: arbitrators' relationship with this increasingly ubiquitous, rapidly-changing technology. This innovative book applies journalism's "5 W questions" to the underexplored issue of arbitrators' digital competence. It reaches a workable definition of what digital competence in the current arbitration context is, also providing answers to the essential question of why arbitrators' digital competence is relevant from legal and financial points of view. Attention then shifts to who, with

reflections on arbitrators working in a highly technological context and clarification of their relationship with other legal and non-legal actors. The book equally offers an in-depth comparative study of the question of where arbitrators' technological competence is regulated, with critical analysis of soft and hard law provisions that may impose a digital competence duty. Finally, the book specifies when arbitrators need to be digitally competent and develops legal proposals regarding key procedural stages (initial conference, hearings) and legal topics (cybersecurity, data protection).

The \$11 Billion Dollar Question in The Federal Republic of Nigeria v. Process & Industrial Development: A Cultural Analysis

"You want to tell us you don't want to sow, you want to reap" asked the Nigerian appointed arbitrator, Chief Bayo OJO, during oral argument in the arbitration proceedings, to which Nigerian counsel, Chief Ayorinde, responded: "You cannot reap where you do not sow. That is a very Nigerian saying." (Nigeria v. Process & Industrial Development, para. 360). The Chair of the Tribunal, Lord Hoffmann, then intervened with his own cultural reference and said: "There is a passage in I think it is Shakespeare's Henry VI where one of the rebels says: 'Isn't it terrible that people should be able to get into such trouble just by signing a document? Let's kill all the lawyers."" (Nigeria v. Process & Industrial Development, para. 360). Perhaps, underneath all the arbitral extravagance and incalculable network of disturbing corruption lurks a least appreciated cultural milieu worth \$11 billion dollars.

ALAN R. CRAIN, JR. is an independent arbitrator, having served in more than 100 arbitrations under a variety of rules. He is a member of the Executive Committee of the Institute for Transnational Arbitration and has served on its Advisory Board for over 20 years. Mr. Crain was an adjunct professor of international law at the University of Houston for 10 years and lectured for nine years at Stanford University Law School. He has also taught on multiple occasions at Duke University, the University of Texas, and the Fletcher School at Tufts University. He is currently an adjunct professor

at the Graduate School of Business at Rice University. He has served on the boards of directors of numerous companies, including multi-billion dollar publicly listed entities, private companies, and start-ups. Mr. Crain began his career with a law firm in Washington, D.C. He has been General Counsel of three Fortune 500 multinationals in the fields of energy, technology, and manufacturing. He has had global responsibility for legal affairs, government relations, crisis
