

# FIELD TRIP HOSTED BY THE UNIVERSITY OF OKLAHOMA MEWBOURNE COLLEGE OF EARTH AND ENERGY

The Mewbourne College of Earth & Energy provides an academic environment in earth sciences and engineering, energy education and research that contains the full breadth of the University of Oklahoma educational experience. Their key service mission is to investigate the State of Oklahoma's land, water, mineral and energy resources.

## 2:30 NATIONAL OILWELL VARCO (NOV) DRILLING SIMULATOR

The NOV Drilling Simulator is a digital drilling simulator which mimics offshore drilling rigs currently in use. The simulator, which is the same equipment used to train professional drillers, is comprised of three chairs with joystick controls for a driller and two assistants, and a "driller's view" projected onto a wall-sized screen featuring Mitsubishi DLP technology – similar to that used in the video screens at the Dallas Cowboy Stadium.

### 3:45 OKLAHOMA PETROLEUM INFORMATION CENTER (OPIC)

OPIC, the Oklahoma Petroleum Information Center, houses more than 100 miles of core from almost 10,000 Oklahoma wells, samples from over 50,000 wells, well logs, production reports, and other material vital to petroleum exploration and production. The collection resides in 192,000 square feet of space in Norman, Oklahoma, and is available to users through on-site visits by appointment. The collection contains information, maps and materials useful to industry, academia, scout and school groups, landscapers and civic planners, hunters and fishers, hikers, and those needing topographic maps.
